Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN.

By submitting entry you agree to and accept these Official Rules and the decisions of Rosedale Center and Jones Lang LaSalle which are final. The "Drawing" is on-going and winners will be selected each month on the first Tuesday of that month for the proceeding month winner. 1. How To Enter and Eligibility.
